# 2. <u>Call to Order/Pledge of Allegiance – Agenda #2</u>

# 3. Approve Minutes – [2/15/23 Regular Board Meeting] – Agenda #3

Mr. Petroccelli moved the Board accept the recommendation of the Superintendent and approve the minutes of the February 15, 2023, Regular Board of Education Meeting.

Motion seconded by Mr. Nafey and carried 7 – 0.

# 4. Board Committee Reports 2022-2023 – Agenda #4

#### Audit:

Mrs. Crowley reported that the Audit committee met on February 21, 2023, and reviewed the draft internal audit report. The Board received a copy of the report as well as the Corrective Action Plan for the audit. The internal auditors were in District on March 13, 2023, to begin their work on the agreed upon risk assessment. The next committee meeting will be set up when the internal auditors have completed their work and have a draft report for the District.

### **Budget:**

Mr. Devincenzi reported that the District received the final health insurance rates which will assist the District in balancing our budget. Assuming that the State budget is on time we should have our final State Aid numbers by the end of the month. A Special Budget meeting has been scheduled for Wednesday, March 22, 2023, at 6:00 p.m. in the High School Library to further discuss the development of the 2023-2024 budget.

Mr. Castle stated that he is optimistic about the District's proposed 2023-2024 budget since the Assembly and Senate accepted the Governor's increase in Foundation Aid. This will help keep the tax levy at or below the tax cap which will benefit the taxpayers. The District will continue to maintain programs that are conducive to learning while also addressing mental health needs of our students.

Mr. Petrocelli asked Mr. Castle what other cohort Districts are doing to address student mental health issues. Mr. Castle shared that other districts are facing the same challenges and are doing the same things to address the mental health challenges of students. He mentioned that he recently read an article in NYSSBA's On Board about a survey the CDC did on the mental health challenges of our youth and that it's a nationwide problem. Mr. Castle feels that part of the problem facing students today is the "noise" created by social media and Mr. LoCicero commented that they have no time for decompression. The District will be hosting a forum on March 27, 2023, that includes a presentation by trooper Watt on the dangers of social media. He encouraged parents to attend.

# Buildings & Grounds:

Mr. Frisbie reported that the Buildings and Grounds Committee has not met since the last meeting. The District opened bids on March 14<sup>th</sup> and they are being analyzed by our construction manager and the District's architect and engineering firm. The District anticipates awarding bids at the Special Board meeting on Wednesday, March 22, 2023. The next committee meeting is scheduled for March 21, 2023, at 6:00 p.m. at District Office.

Mr. Castle indicated that the bids will be discussed at this meeting and the challenges facing the industry to find workers. He commented that there weren't many bids due to a diminished workforce available to perform the jobs.

#### CDEP:

Mr. White reported that the CDEP Committee met on February 22, 2023. In the morning, Mr. White shared the plan for the District's remote instruction for emergency conditions. This plan will be included in the District-Wide School Safety Plan. The District plan is to use all emergency days first prior to using remote instruction, unless it is needed for extenuating circumstances, (example, water main break, no heat in a building, etc.).

The elementary principals (Mrs. Harjes, Mr. Brown and Mrs. Hasbrouck) presented on the exploration of English Language Arts (ELA) plus one (1) for grade 4. We currently use this model in grades 5 and 6. They shared the rationale for the change, the benefits and barriers, and the communication plan to implement the model for grade 4 in the 2023-2024 school year.

Ms. Rounds presented an update to the work that the RtI/MTSS (response to intervention/multi-tiered system of supports) Committee is completing. Mr. White shared how the District is exploring the implementation of Universal Pre-Kindergarten (UPK) for the 2023-2024 school year. He explained the options being explored for UPK and a timeline.

In the afternoon, each School Improvement Team (SIT) reported out on the progress of their 2022-2023 School Improvement Plans and shared the School Improvement Plans developed for the 2023-2024 school year. The elementary School Improvement Plans were presented to the Board at the March 15<sup>th</sup> Board of Education and a copy of the plans were provided. The High School Middle School and Special Education School Improvement Plans will be presented and shared with the Board at the April 18<sup>th</sup> Board of Education meeting.

The CDEP committee is not scheduled to meet until the 2023-2024 school year.

### Curriculum/TAG:

Mr. White reported that the Curriculum/TAG Committee was scheduled to meet on March 14, 2023; however, due to a snow day the Curriculum/TAG committee meeting has been rescheduled for March 28, 2023, at 3:30 p.m. in high school room 102.

#### Health & Safety:

Mr. Palen reported that the Health and Safety Committee met on March 9, 2023. The committee discussed and reviewed a draft of the 2023-2024 District-Wide Safety Plan. The next committee meeting is scheduled for April 13, 2023, at 4:00 p.m. in high school room 104.

#### Legislative:

Mr. Petroccelli reported that the Legislative Committee has not met since the last meeting.

#### Policy:

Mr. Palen reported that the Policy Committee met on March 9, 2023 and reviewed several policies. There are eight (8) policies on the March 15<sup>th</sup> Agenda for first reading. The next committee meeting is scheduled for May 4, 2023, at 6:00 p.m. in high school room 102.

# Technology:

Mr. Bartolone reported that the Technology Committee has not met since the last Board meeting. The next committee meeting is scheduled for April 24, 2023, at 3:30 p.m. in high school room 102.

# Wellness:

Mr. Nafey reported that the Wellness Committee has not met since the last Board meeting. The next committee meeting is scheduled for April 18, 2023, at 3:30 p.m. in high school room 102.
