Wallkill High School Names Valedictorian and Salutatorian for Class of 2024

WALLKILL SENIOR HIGH SCHOOL (WSHS) IS PROUD TO ANNOUNCE THAT ANDIE PSILOPOULOS IS VALEDICTORIAN AND TREVOR STRANO IS SALUTATORIAN OF THE CLASS OF 2024. These students have not only excelled in their academic pursuits, but have also made outstanding contributions through community endeavors and extracurricular activities.

WSHS Principal Brian Masopust has high praise for both students. "Andie is naturally gifted in both

academics and athletics. But perhaps what is most impressive about Andie is her drive, discipline, competitiveness, and will to succeed," he said. "Trevor," he added, "excels in academics, athletics, and music and has made giving back to his school community a priority. His future is bright, and he will succeed in anything that he dedicates himself to."

Andie, the daughter of Karen and Kris Psilopoulos of Gardiner, leads her class with a 101.43 grade point average (GPA). Taking

honors, advanced placement (AP), and college-level classes, she has received academic excellence awards in Math, Social Studies, Foreign Language, and Health. She has served her classmates as the vice president of National Honor Society, treasurer of Spanish Honor Society, and secretary for the Class of 2024.

Beyond the classroom, Andie has been a leader as well, being named captain of the Varsity Swimming,

Nordic Ski, and Track teams. She is a two-time Section IX Champion for Nordic Skiing, earning league champion status for Swimming and Track. "I am grateful to my coaches, especially Nordic Ski Coach Nick Mancuso, for pushing me outside my comfort zone and never accepting less than 100%," she said. This work ethic helped earn Andie the title of All-American triathlete at the World Triathlon Championships in Germany, where she competed for Team USA last summer.

In addition to crediting her parents for helping her to

become the person she is today, Andie is grateful to the many educators at WSHS who pushed her to be the best version of herself, including AP Calculus teacher Stephanie Barnes, Algebra II teacher Kimberly Earl, and AP U.S. History teacher Margaret Pelosa.

This fall Andie plans to study biology at Duquesne University in Pittsburgh, where she will also Triathlon team. Andie hopes to attend medical school and to one

Club. Trevor calls his parents, Michael and Kimberly Strano, and siblings Michael and Hannah, his biggest supporters.

Trevor has fond memories of playing clarinet in school concerts and caroling through the halls of the High School. His eight-plus years of music lessons have, he said, taught him the value of effort and persistence. This hard work helped him achieve chairs in the All-County and Area All-State Bands. He is thankful to his Band teachers, Grade 8 Band teacher Adam Kuliszewski, and WSHS Band teacher Ashley Contzius, along with his private music instructor, Sonia Nosovsky.

Golfing has also taught Trevor important life lessons. A member of the Varsity Golf team since Grade 7, Trevor was named captain in Grade 11 and has earned medals in the Metropolitan Junior PGA and U.S. Kids Golf tournaments. "Golfing," he said, "has taught me to think positively when faced with hardships." He is grateful to Golf Coach and Athletic Director William Earl and Coach Andy Crane, as well as his employer and Turtle Creek Golf Course owner Jennifer Salemo, for all they have

A Message from the Superintendent

Dear Wallkill Community,

The Wallkill Central School District Board of Education and Administration have worked diligently over the past several months to prepare the proposed 2024-2025 school district budget. The District is proposing a 4.68% budget increase for the 2024-2025 school year that equates to a 2.47% tax levy increase (below the tax levy limit). As a result of the fiscal foresight of the Board of Education and Administration, our proposed 2024-2025 budget will result in a tax levy that is either at or below the limit for the 13th year in a row. In fact, this is the 4th year in a row that we are below the limit. Since the proposed tax levy is below the tax levy limit, the proposed budget will require a simple majority of voters for approval (50% +1) instead of a super majority for approval (60% or more).

The 2024-2025 proposed budget will maintain:

- All programs and extra-curricular activities for students
- ▶ All instructional and non-instructional positions
- The current structure of the Universal Pre-Kindergarten (UPK) program (84 slots)
- Low class sizes in grades K-12 to allow for enhanced learning opportunities (K-6 average class size of 20)
- Professional Development opportunities to support classroom instruction and student learning
- ▶ Support services to address the mental health and academic needs of our students
- Police officers in all five (5) buildings

In addition to the above, the budget includes an additional School Psychologist to meet the needs of our students with disabilities, as well as the increasing mental health needs of our students.

This issue of *Learning at Wallkill* provides the public with valuable information on District program highlights, the candidates who are running for the Board of Education, and the proposed 2024-2025 school district budget.

I would like to take this opportunity to thank all District residents for your continued support of our students! Stay Panther Strong!

Frequently Asked Questions about the 2024-2025 School District Budget

What is the proposition to be voted on?

The proposition voters will cast a ballot for on Tuesday, May 21, 2024, will be:

Proposition #1: RESOLVED, that the proposed Wallkill Central School District budget for the 2024-2025 school year in the amount of \$89,466,000 be approved and the Board of Education of said School District be authorized to levy the necessary tax therefore.

Is the Wallkill Central School District's 2024-2025 tax levy within the limit?

Yes, the 2024-2025 tax levy is below the allowable limit by \$262,655; therefore, a simple majority of voters is needed for budget approval (50% + 1). The tax levy increase with permissible exemptions is 2.47%.

What is the tax levy limit?

Essentially, it is an eight-step formula that each school district must use to calculate the tax levy limit. The result (the limit) is the maximum allowable tax levy (including permissible exemptions) that a school district can propose and would require only the approval of a simple majority of voter (50% + 1). Any proposed tax levy amount above the limit would require budget approval by a super majority (60% or more) of voters. Does the tax levy indicate how much my taxes will rise?

No, the tax levy is the amount of money the school district can raise through property taxes. The amount an individual will pay toward the levied amount is the tax rate. Tax rates paid by individual taxpayers may differ greatly from one household to another based on such things as equalization rates and total town assessed values.

What strategies were used to have a tax levy within the tax cap?

- 1. Projected increase in State Aid
- 2. Lower health insurance renewal rates
- 3. Use of fund balance and reserves
- 4. Multi-year financial planning

What is the percent increase of the proposed 2024-2025 budget when compared to the 2023-2024 budget?

The 2024-2025 budget increase is 4.68%.

How much State Aid is the District projected to receive?

The District is projected to receive \$38,000,000 in State Aid in 2024-2025. In addition, the District continues to balance its budget with reserves and fund balance.

What programs for students are included in the 2024-2025 budget?

- 1. Maintain programs and extra-curricular activities
- 2. Maintain all instructional/non-instructional positions
- 3. Maintain the current structure of the UPK program (84 slots)
- 4. Add one (1.0) FTE School Psychologist to address the needs of our students with disabilities and the increasing mental health needs of our students
- 5. Maintain low class sizes for K-12 to allow for enhanced learning opportunities (K-6 average class size of 20)
- 6. Professional Development opportunities to support classroom instruction and student learning
- 7. Maintain support services to address the mental health and academic needs of our students
- 8. The continued assignment of Police Officers in all five (5) school buildings

What happens if voters reject the proposed budget?

If voters reject the proposed budget, the school district may put up a revised budget for a second vote or adopt a contingent budget.

What additional programs/positions will be reduced if the budget fails (contingent budget)?

- ► Reduction of seven (7) instructional positions resulting in larger class sizes and loss of programs for our students
- ▶ Reduction of one (1) school psychologist
- ► The UPK program
- All field trips (including Ashokan)
- ► All equipment (except for technology equipment for instructional purposes and equipment necessary for health and safety purposes)
- Charges to community groups that result in identifiable costs for use of buildings

What is included, as allowed by New York State Education Law, in a contingent budget?

A contingent budget will allow:

- ► All regular transportation to and from school at current levels of more than .6 miles and to private/parochial schools
- ► All legal obligations
- ► All health and safety repairs
- ▶ All expenses to maintain mandated educational programs
- ▶ All other budgeted items as determined by the Board of Education

Who can vote on May 21, 2024?

Voters are eligible to vote if they are: (a) a U.S. Citizen; (b) at least 18 years of age; (c) a resident of the school district for at least 30 days prior to May 21, 2024; and (d) not otherwise ineligible to vote under Section 5-106 of the Election Law. Individuals do not need to be registered to vote. Learning to Grow at Plattekill Elementary with Greenhouse Revitalization

tudents at Plattekill Elementary School (PES) are once again growing flowers and vegetables in their school greenhouse, and staff is finding ways of incorporating this unique space into the curriculum.

The PES greenhouse was originally built in 2005 by parents and volunteers from the Ulster YouthBuild program, who used a kit that had been purchased through a grant from Assemblymember Kevin Cahill. "We were utilizing the greenhouse until spring of 2020," explained Principal Monica Hasbrouck. "During COVID the Greenhouse was unable to be utilized, but as a goal for the school we have begun to make the updates needed to bring it back to a fully functioning greenhouse."

Several issues had to be addressed as part of the revitalization plan, including making sure that the mechanical parts were



Students from Melissa Space's Kindergarten class check on the plants sprouting from vegetables seeds they had planted.


operating properly and ensuring that the heating system was working. Necessary window repairs were made, and additional gutters were added.

Wallkill Central School District Physical Therapist Fritz Meier volunteered his time to clean up the greenhouse. He built additional planter boxes with lumber donated by Sedmak Custom Contracting and created a trellis for the string beans. Mr. Meier also constructed an irrigation system for watering the plants, using a hose, weights, and a timer for days when school is not in session.


"We also wanted to incorporate the greenhouse into our curriculum," said Mrs. Hasbrouck, who noted that Ulster BOCES Model Schools Content Specialist Shelley Cuccia worked with Grade 3 teacher Breanna Friedman to curate a book of lessons focused on plants and on utilizing the greenhouse.


Learning about the process of composting will be one of those lessons, with the Ulster County Resource Recovery Agency visiting classes this spring to teach students more about how they can recycle food scraps and plant material into fertilizer. Mrs. Hasbrouck expects to include greenhouse activities, such as collecting food waste from the cafeteria, as student job options for the next school year. "We really want the students to get involved and take advantage of this wonderful resource," she said.

THE 2024-2025 SCHOOL BUDGET, which is being proposed to Wallkill residents on May 21, 2024, will include the current Universal Pre-kindergarten (UPK) program available to four (4) years olds who reside in the District. The program will include one (1) section at Plattekill and Ostrander Elementary Schools, with a maximum class size of eighteen (18) students per section and forty-eight (48) slots assigned to

Community-Based Organizations [Building Blocks (8) and Most Precious Blood (40)]. As a result, there will be eighty-four (84) slots available in the 2024-2025 school year.

Please be advised that our in-house UPK program is contingent upon the passing of the 2024-2025 school budget on Tuesday, May 21, 2024. In addition, District transportation will not be provided for the program.

The District will hold a random lottery to determine enrollment in the proposed UPK program. All eligible
applicants will be entered individually into the lottery. The lottery will be held Wednesday, May 29, 2024, at 4:00 PM.
Access to the lottery will be via the Wallkill Central School District website.

Please note that you will be offered the opportunity to select a preferred location on the UPK application, which will be determined by the lottery selection process.

To be eligible for the lottery:

- → You must be a resident of the Wallkill Central School District.
- → Your child must be four (4) years old on/before December 1, 2024.
- → You must complete and submit the lottery application form to the Wallkill Central School District Office for Educational Services by Friday, May 17, 2024, by 3:00 PM.

All families will be notified of their child's status on Monday, June 3, 2024. Any student not selected in the lottery for a seat will be placed on a waiting list.

Students were encouraged to bring the challenge home as well. The next day at school, they participated



The Jump into Health event for students from Kindergarten through Grade 6 was organized by Physical **Education instructors Thomas Palazzo** and Joseph Kutcha. They, along with 16 student assistants from Wallkill Senior High School's chapters of the National Honor Society and the Spanish Honor Society, supervised and guided students while reinforcing the importance of exercise as part of a healthy lifestyle. In fact, as Mr. Palazzo told the participants, "Jumping rope for 10 minutes straight can roughly equate to the energy needed to run a mile."

As students skipped rope, Mr. Palazzo explained why this activity is one of the best workouts you can

do. "Jumping rope is a great way to get exercise," he said. "You can do it anywhere, you don't need a lot of space, and the only equipment you need is a jump rope." Students at OES start practicing their jump roping

skills in Kindergarten and continue throughout their time at the school. "It doesn't matter if you already know how to jump rope or not, you will get better through practice," Mr. Palazzo added.

Students tried a variety of jumping techniques throughout the event, including skipping backwards, turning in a circle, and even jumping on one leg! Because jumping rope requires upper and lower limb coordination, it is multifunctional exercise that can be used for fitness, recreation, or competition. At the end of the event, students were provided with a healthy snack of apples and pretzels and reminded to drink plenty of water.

OES Principal Alyssa Greany was full of praise for the event and those who participated in it. "This is a fantastic way to bring students

together," she said. "They are also having fun and encouraging each other, which is great to see."
